## **ACCOMPLISHMENTS:**

TED Newsletter now has an "opt out" policy. All new TED members are inputted into the newsletter monthly and all members who select not to receive the newsletter can "opt out" via the unsubscribe link.

TED Website additions were completed

Ad Hoc committee work culminated in the summer of 2019. The Policy Group developed an HEA policy brief but recommended it not be adopted by TED given the change in federal interest and aim toward reauthorization of the legislation.

Solicited, reviewed (with the support of Kaleidoscope), selected, on-boarded 19 TED members to participate in SELS. Through attrition, we had 18 people attend SELS.

Although we had two cases of attrition, TED funded 10 doctoral students to attend SELS and supported all 10 with webinars and on-going communication pre and post SELS.

Although we had three cases of attrition, TED funded 8 members to participate in SELS including webinars and pre/post communication.

This year we received the MOST applications for the Jane West SPARK award than ever before! We selected one nomination that stood above the rest and coordinated with the President and Jane to deliver the award.

# **OUTCOMES:**
